

## Travel Drumheller Board Application

Thank you for expressing an interest in being a director on the Travel Drumheller Board. The board comprises 12 members. Four members are appointed by the organizations who formed Travel Drumheller and do not come up for election. This is a voluntary position on a governing board with one employee – the Executive Director. All directors are required to attend quarterly meetings and will be expected to be part of any working committees when required and asked to represent the organization at events.

To be eligible to stand for election to the Board you and/or your business must have made a financial contribution to the organization, such as purchasing a partnership, collecting DMF funds and/or purchasing an ad in the Guide.

The Nominating Committee will assess all applicants based on the application below. An important consideration will be ensuring a cross section of representation from within the tourism and hospitality industry is maintained to keep the board balanced.

## **Travel Drumheller Board mandate**

The Board of Travel Drumheller is a governance board. This means members of the board are responsible for the strategic direction of the organization. They are not responsible for day-to-day operations. They have one employee and that is the Executive Director. The Executive Director is responsible for all staffing and operations of the organization. They work with the Executive Director to determine the strategic direction and priorities for Travel Drumheller. Travel Drumheller is just working on a new 4 year strategic plan which will be launched at the Annual General meeting. This will be the road map for the organization over that period of time.

Travel Drumheller is a registered not for profit with a set of bylaws which are reviewed on a regular basis.
